### Personal precautions, protective equipment and emergency procedures

**General measures**: This product contains a material of biological origin. Use universal precautions during clean up procedures. Avoid breathing (vapor, mist). Use only in a well-ventilated area. #### For non-emergency personnel

### Methods and material for containment and cleaning up

**Small spill:** Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Large spill: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g., sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13).
