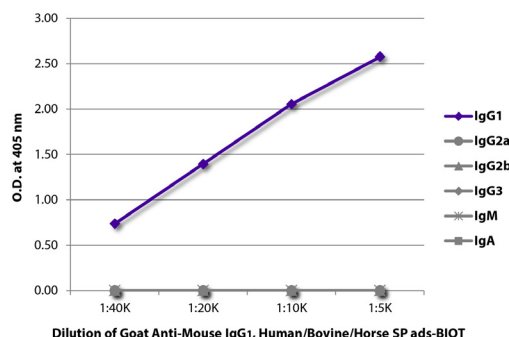

ELISA plate was coated with purified mouse IgG₁, IgG_{2a}, IgG_{2b}, IgG₃, IgM, and IgA. Immunoglobulins were detected with serially diluted Goat Anti-Mouse IgG₁, Human/Bovine/Horse SP ads-BIOT (SB Cat. No. 1073-08) followed by Streptavidin-HRP (SB Cat. No. 7100-05).

Description

Specificity	Reacts with the heavy chain of mouse IgG ₁
Source	Pooled antisera from goats hyperimmunized with mouse IgG ₁
Cross Adsorption	Mouse IgG _{2a} , IgG _{2b} , IgG ₃ , IgM, and IgA; human, bovine, and horse serum proteins (SP); may react with immunoglobulins from other species
Purification	Affinity chromatography on mouse IgG ₁ covalently linked to agarose

Handling and Storage

- The purified (UNLB) antibody is supplied as 1.0 mg purified immunoglobulin in 1.0 mL of borate buffered saline, pH 8.2. *No preservatives or amine-containing buffer salts added.* Store at 2-8°C.
- The fluorescein (FITC) conjugate is supplied as 1.0 mg in 1.0 mL of PBS/NaN₃. Store at 2-8°C.
- The alkaline phosphatase (AP) conjugate is supplied as 1.0 mL of stock solution in 50 mM Tris/1 mM MgCl₂/50% glycerol, pH 8.0, containing NaN₃ as preservative. Store at 2-8°C or long-term at -20°C.
- The horseradish peroxidase (HRP) conjugate is supplied as 1.0 mL of stock solution in 50% glycerol/50% PBS, pH 7.4. No preservative added. Store at 2-8°C or long-term at -20°C.
- The biotin (BIOT) conjugate is supplied as 1.0 mg in 2.0 mL of PBS/NaN₃. Store at 2-8°C.
- The Alexa Fluor[®] 488 (AF488), Alexa Fluor[®] 555 (AF555), and Alexa Fluor[®] 647 (AF647) conjugates are supplied as 1.0 mg in 1.0 mL of PBS/NaN₃. Store at 2-8°C.
- Protect fluorochrome-conjugated forms from light. Reagents are stable for the period shown on the label if stored as directed.
